US trade officials finalized steep tariff levels on most solar cells from Southeast Asia, a key step toward wrapping up a year-old trade case in which American manufacturers accused Chinese.

On April 21, 2025, the U.S. Department of Commerce finalized new tariffs on solar panels and components imported from Malaysia, Thailand, Cambodia, and Vietnam. The decision stems from findings that certain Chinese companies circumvent existing tariffs using factories in these countries. Here's.

According to IRENA, the global weighted average cost of electricity from utility-scale solar PV has fallen by 85% between 2010 and 2020, followed by concentrating solar power by 68%. Today, solar power is one of the cheapest forms of electricity, according to the IEA, and is significantly more.

Countries like India, Vietnam, Malaysia, Thailand, and the Philippines aren't just installing more solar panels — they're producing them at competitive rates that are shaking up global prices. BEIJING, Dec 2 (Reuters) - A new round of U.S. solar panel import tariffs on Southeast Asian producers is expected to raise consumer prices and cut into producer profit margins, but was largely anticipated by industry, analysts said.

Are Chinese solar companies working in Southeast Asia to avoid tariffs?

A group of U.S. manufacturers, calling themselves the American Alliance for Solar Manufacturing Trade Committee, first filed the AD/CVD petition in April 2024, claiming that primarily Chinese solar companies were working in

Southeast Asia to avoid paying existing tariffs on Chinese goods.

Did China 'dump' cheap solar panels into US market?

US officials say Chinese producers have used Southeast Asian countries to skirt tariffs on China and “dump” cheap solar panels in the US market, harming their businesses.

What is the tariff rate on solar panels in Vietnam?

Additionally, all imported solar panels from Cambodia face a tariff rate of 117.12%, while exporters in Vietnam not specifically identified by the DoC, are subject to a 271.28% rate. The DoC will make its final determinations on 18 April 2025 and issue its final orders on 9 June 2025.

How did Chinese solar panels avoid tariffs?

Companies Were Avoiding Tariffs The U.S. had already imposed taxes on Chinese solar panel makers when they sold products to American buyers. To avoid those tariffs, the companies began using factories in Southeast Asia. However, the same Chinese companies own or control many of those factories.

Are Southeast Asian solar imports harming the domestic industry?

The ITC did preliminarily decide that the Southeast Asian solar imports were harming the domestic industry, and Commerce revealed its preliminary CVD amounts in September and its preliminary AD amounts in November.
