Who is responsible for exporting products to the Netherlands?

When exporting products to the Netherlands from outside the EU, your representative inside the EU is usually responsible for lodging the customs declaration. This officially turns the products from non-EU goods to EU goods. In some cases you can be responsible: for example, if you and your importer agree on the Incoterm® Delivered Duty Paid.

Do you have to pay taxes when importing goods into the Netherlands?

Customs officials carry out checks to determine whether travellers and businesses are required to pay taxes when importing goods. When importing goods into the Netherlands from outside the European Union (EU), you will usually have to pay import duties. You will also have to pay VAT and in some cases excise duty, consumption tax or other levies.
