What does Zambia export?

Other than copper, which accounts for 70% of the country's total exports, Zambia exports sugar, tobacco, gemstones, cotton and electricity. Based on data from ZamStats, Zambia's main export trading partners are Switzerland (45% of total exports), China, DRC and South Africa.

Why is Zambia a good place to ship from Germany?

One of the particularities of Zambia, as mentioned earlier, is that the country does not have direct access to the sea. The best port for the shipment of a container of goods or products from Germany or any part of Europe to Zambia is through the port of Walvis Bay, Namibia, because of its shorter distance to Europe.

What products does Zambia import?

Zambia's main import products are refined copper, refined petroleum, crude petroleum, nitrogenous fertilisers and mixed mineral or chemical fertilisers. The main source countries for Zambia's imports are South Africa, China, United Arab Emirates (UAE), India and DRC.

Which ports are used to ship goods to Zambia?

However, Dar Es Salaam is the port of choice for goods coming from Asia. Some of the ports that are used for shipping goods destined for Zambia are Durban, East London and Port Elizabeth (South Africa) and Beira and Nacala (Mozambique).

Can a company have a foreign shareholding in Zambia?

According to Companies Act No. 10 of 2017, at least half of the company's directors need to be resident in Zambia but they need not be Zambian

nationals. There are generally no restrictions on foreign shareholding for companies in Zambia.
